PamperBook ("We") are committed to protecting and respecting your privacy. This policy (together with our terms of use and any other documents referred to on it) sets out the basis on which any personal data we collect from you, or that you provide to us, will be processed by us. Please read the following carefully to understand our views and practices regarding your personal data and how we will treat it. Information we may collect from you We may collect and process the following data about you: Information you give us. You may give us information about you by filling in forms on our site www.pamperbook.co.uk ("Site") or by corresponding with us by phone, e-mail or otherwise. This includes information you provide when you register to use our site, subscribe to our service, make a booking with one of our providers, place an order on our site, participate in discussions board and any other activities commonly carried out on the Site. The information you give us may include your name, address, e-mail address and phone number along with your financial and credit card information or PayPal details. Information we collect about you. With regard to each of your visits to our site we may automatically collect the following information: technical information, including the Internet protocol (IP) address used to connect your computer to the Internet, your login information, browser type and version, time zone setting, browser plug-in types and versions, operating system and platforms Information about your visit, including the full Uniform Resource Locators (URL) clickstream to, through and from our site (including date and time); products and providers you viewed or searched for, page response times, download errors, length of visits to certain pages, page infraction information (such as scrolling, clicks and mouse-overs), and methods used to browse away from the page and any phone number used to call our customer service number. following ways: Information you give to us. We will use this information: to carry out our obligations arising from any contracts entered into between you and us and to provide you with the information, products and services that you request from us; to provide you with information about other goods and services we offer that are similar to those that you have already purchased or enquired about; to provide you, or permit selected third parties to provide you, with information about goods or services we feel may interest you. If you are an existing customer, we will only contact you by electronic means (e-mail or SMS) with information about goods and services similar to those which were the subject of a previous sale or negotiations of a sale to you. If you are a new customer, and where we permit selected third parties to use your data, we (or they) will contact you by electronic means only if you have consented to this. Information we collect about you. Information we receive from other sources. We may combine this information with information you give to us and information we collect about you. Disclosure of your information We may share your personal information with any member of our group, which means our subsidiaries, our ultimate holding company and its subsidiaries, as defined in section 1159 of the UK Companies Act 2006. We may share your information with selected third parties including: Business partners, suppliers and sub-contractors for the performance of any contract we enter into with you. This will mainly be our Providers and these will be chosen by you when you book an appointment. Advertisers and advertising networks that require the data to select and serve relevant adverts to you and others. We do not disclose information



about identifiable individuals to our advertisers, but we may provide them with aggregate information about our users Analytics and search engine providers that assist us in the improvement and optimisation of our site. We may disclose your personal information to third parties: In the event that we sell or buy any business or assets, in which case we may disclose your personal data to the prospective seller or buyer of such business or assets. If PamperBook or substantially all of its assets are acquired by a third party, in which case personal data held by it about its customers will be one of the transferred assets. If we are under a duty to disclose or share your personal data in order to comply with any legal obligation, or in order to enforce or apply our terms and conditions and other agreements; or to protect the rights, property, or safety of PamperBook, our customers, or others. This includes exchanging information with other companies and organisations for the purposes of fraud protection and credit risk reduction. Where we store your personal data The data that we collect from you may be transferred to, and stored at, a destination outside the European Economic Area ("EEA"). All information you provide to us is stored on our secure servers. Any payment transactions will be encrypted using SSL technology.
